Dear Businessperson:

The Department of Revenue has received and processed your Master Application. Based upon the information you provided, your business meets the criteria to be assigned Active Nonreporting status. Your account will remain open but you will not be required to file tax returns.

A business qualifies for Active Nonreporting status by meeting ALL the following requirements:

- \* The business activity does not require the collection of sales tax;
- \* Gross income or value of products sold, subject to business and occupation (B&O) tax, is less than \$28,000 per year;
- \* Gross proceeds of sales, gross income, or value of products subject to public utility tax is less than \$24,000 per year;
- \* No other tax or fee is required to be collected or paid to the Department of Revenue.

If your business gross exceeds the \$28,000 threshold, collects retail sales tax or owes use tax, please call Customer Account Services at (360) 902-7180 to change your account status immediately. You will be assigned a reporting frequency and sent tax returns.

It is your responsibility to maintain financial records on your gross receipts and notify the department if your business no longer meets these requirements. If at any time you no longer meet the requirements listed above, a tax return must be filed and any tax due paid. If you incur a tax liability and do not notify the department, the tax due plus penalties and interest may be assessed.

If you need further assistance on taxation, or reporting requirements, or wish to close your account you may call Customer Account Services (360) 902-7180 or your local Revenue office.
