General Conditions and Guidelines  
for  
Use of Capitol Campus Facilities


1. **General Use:** The buildings and grounds of the Washington State Capitol Campus are owned by the public for the purpose of conducting the business of state government. The business of government encourages public participation and involvement, and therefore access and use of state owned facilities. The priority use of state owned facilities shall be for activities related to state government.
2. **Laws and Rules:** Users of Washington State Capitol Campus facilities shall comply with all state and federal laws and regulations, City of Olympia ordinances, and requests of the Department of General Administration representatives made to prevent injury or damage on the permitted premises.
3. **Condition of Premises:** All materials, supplies, equipment or resulting debris shall be removed from the area upon conclusion of your activity. Please be aware you may be held responsible for any expense that might be incurred in cleaning up or repairing the area as a result of your activity.
4. **Indemnity:** State of Washington, Department of General Administration is not responsible for any damage or injury to members of your group due to your use of or presence on state property.
5. **Responsibility:** The permitted organization or individual assumes responsibility for all activities conducted, including supervision and control to prevent injury or damage; conduct during the event complies with state and federal laws and city ordinances, maintenance of the premises during the use, coordination with General Administration staff.
6. **Departmental Access:** Authorized representatives of the Department of General Administration, Washington State Patrol and Olympia Police Department shall have free access to premises at any and all times. Should the Department's representatives determine any safety or security concerns, the representative will intercede if necessary calling on emergency or law enforcement resources.
7. **Sales and Solicitations:** No sales, solicitations, or commercial activities shall be engaged in on the Capitol Campus except with prior approval of the Director of General Administration. Reference WAC 236-12-150.
8. **Camping on state capitol grounds is prohibited.** WAC 236-12-435.
9. **Ingress and Egress:** No person, singly or in combination with others, shall engage in demonstrations or parades in such a manner as to disrupt the orderly flow of pedestrian or vehicular traffic on the state capitol grounds or the conduct of state business by state employees on the state capitol grounds or in any buildings on the state capitol grounds. WAC 236-12-430.
10. **Rallies and demonstrations may not take place inside state buildings.** Sticks and signs are not permitted in state buildings. Signs and placards may not be placed in the ground on state capitol grounds.

11. Event organizers on the Capitol Campus, Sylvester Park, Heritage Park, and Marathon Park shall be in compliance with Olympia Municipal Code 18.40.080 and WAC Chapter 173-60 "Maximum Environmental Noise Levels. Organizers should have a person in charge of sound levels and have a sound meter to monitor amplifications. Authorized representatives from the Department of General Administration or Washington State Patrol will contact event organizers in the event of sound complaints.
12. Consumption of alcoholic beverage shall not be permitted in the public areas of the Capitol Campus and State Buildings. RCW 66.44.100.
13. Generally, no person shall carry any dangerous weapon or firearm on the state capitol grounds or parks.
14. State law forbids the use of public office or agency facilities in campaigns for election of a person to an office and for ballot measures. Facilities of public office or agency include but are not limited to use of stationery, postage machines and equipment, use of employees of the office or agency during working hours, vehicles, office space, publications of the office or agency, and clientele lists of persons served by the office or agency.
15. Open flames, such as candles, are not permitted in State buildings.
16. Helium balloons are not permitted in the Legislative Building.
17. Driving vehicles into any park or any lawn area is not permitted unless authorized. Any damage to lawn, sidewalks or sprinkler systems will be the responsibility of event organizers.
18. Please be advised that because the Legislative Building is the seat of government for the State of Washington, unexpected events relating to state government may arise which could require adjustments in the planning of your event. Our office will be available to assist you should such an occasion arise.


**Supplemental Provisions:**


Dear Ms. DeShaw
