Articles of Incorporation

- 1 The name of the corporation is "The Republican Democracy Party" (RDP).
 - 2 The period of duration is perpetual
 - 3 The purposes for which the corporation is organized is to establish an active, charter-based political party that will convene quarterly caucuses in the precincts and Legislative District Assemblies of Caucus participants using traditional democratic practices while standing for English republican principles and values.
 - 4 The corporation attaches version 43 of the Charter of the Republican Democracy Party dated March 3rd, 2005, and includes it as if fully set forth herein, which said charter is in no ways inconsistent with law. It establishes that:
 - 4.a All assets are to be used for the purposes of the corporation as democratically decided by the membership. All corporate assets will be delivered into the possession of the State of Washington upon dissolution or final liquidation.
 - 4.b The definition, limitation and regulation of the powers of the corporation are established by way of binding covenants upon the membership, guiding principles, a Constitution of structure and process, and rules.
 - 4.c The personal liability of a director to the corporation or its members, if any, for monetary damages for conduct as a director is expressly limited in accordance with law: PROVIDED, That a director shall be liable for acts or omissions that involve intentional misconduct or a knowing violation of law or the Charter Covenants by a director, or for any transaction from which the director will personally receive a benefit in money, property, or services to which the director is not legally entitled.
 - 4.d The inclusion of the attached Charter and its tenets is permitted under title 24 of the RCW.
 - 5 The address of the initial registered address is 6753 Belle vista Place NW, Olympia WA 98502. The initial registered agent at said address is Robert A. Ficalora.
 - 6 Mr. Robert A. Ficalora constitutes in its entirety the initial board of directors, Under the Charter the board shall be comprised of twelve individuals elected annually by the membership from among its state, county and legislative district officers.
 - 7 RDP founder Robert A. Ficalora's address is: 6753 Belle vista Place NW, Olympia, WA 98502.

We the People of the United States of America, being heirs and successor governors of these lands to the original native peoples and to the Protestant kings and queens of England, are endowed with the inalienable rights of a free and sovereign nation. With the understanding that our national liberties are liberties at law, and that the protection thereof requires vigilance and attention, it is by this charter that we do freely assemble for political purposes according to law and establish this body corporate and politic as the Republican Democracy Party (RDP).

I. COVENANTS

All members swear to:

Hold these covenants as higher law and an inviolable contract, accepting membership according to their terms;

Respect the lawful right of other members to dignity, privacy and to peaceable assembly without spying or alienation, and to quietly surrender membership upon a vote of exclusion for breach thereof as more fully set forth in Section V (below).

Faithfully fulfill all party duties and responsibilities undertaken.

Stand for the rule of law, justice, peace and ecological restoration.

Speak only truth while giving love indifferently and opposing contempt for the rights, liberties and Commonwealth of all people or peoples now or ever cognizable under our system of English law.

Practice and espouse active participation and non-violence.

II. PRINCIPLES

The RDP holds that:

Republican government is by the People according to constitutions and laws, and not by banks, corporations, poseurs or monarchy;

Democratic government is of the People with government closest to the People being best;

Constitutional democracy is a contract with all governmental assets of any type or nature being the Commonwealth of the People;

The RDP shall establish strength in state government to assert state sovereignty as a balance to federal power;

A Constitutional amendment shall establish universal education and health care as a personal right;

The most fundamental liberty to make our own laws shall not be impinged or surrendered;

Social security being established by a Federal

Insurance Corporation Act (FICA), all funds are non-discretionary to Congress for other purposes;

The National Guard being the states' militia, must be under the exclusive command of the Governors with foreign adventures only upon their public order.

Standing armies, mercenary forces, military tribunals and unaccountable military industrial and intelligence complexes should be abolished;

All sovereign or prerogative powers not granted to the federal union by thirteen independent and sovereign states are reserved to the states or to the People.

The exploitation of labor, natural resources and technology being necessary for human sustenance, unions and a living wage, environmental restoration and protections of health and safety are essential;

Victimless crimes and pretexts of war for taking greater authority are to be resisted;

Rural and urban communities must be balanced with the countryside protected;

The sanctity of the obligations of contracts, the equal rights and treatment of all persons before the law, and the freedom of conscience in a secular state are essential to our liberty;

All voting in contested partisan elections should be open and published for public inspection with the option provided for privacy;

Acts made or actions taken by governmental bodies without or in excess of their Constitutionally delegated powers to reconstitute government or to extend powers into the states, or over the People, are opposed;

Should the government of the United States continue to operate outside of the powers delegated to it by the federalist Constitution thereof, and the People are strong within their states, a constitutional convention of the states should be convened for the re-constituting of said government, with the Bill of Rights to be considered first and not in any way diminished. III. CONSTITUTION

The Republican Democracy Party (RDP) is a charter-based body politic and corporate to be established as a "Bona fide political party" under the laws of the State of Washington, U. S. A.

The RDP shall maintain committees with a secretary and treasurer for the state and for each of the Legislative Districts and Counties.

A secretary and a treasurer shall be elected by the membership for the state and the Counties and Legislative districts. The twelve members of the Board of Directors of the RDP Corporation shall be elected annually by the membership from among them.

vote being changeable until closing of the agenda item.

The priority of business shall be the deliberation and voting upon pending resolutions followed by the introduction of any proposed new resolutions.

Resolutions adopted by a caucus shall be voted by all caucuses in the legislative district at the subsequent caucuses, and resolutions adopted by the majority vote of a majority of caucuses in the legislative district directed to a city, county or state convention for a vote by all included precincts.

The caucus and convention calendars shall be fixed in a manner most effective in relation to state government.

The legislative district chairpersons shall be selected for one year terms by seconded nominations and voting at the January Legislative District Assemblies with the State chairman to be voted from said chairpersons for a one year term at the subsequent precinct caucuses.

Financial accounts shall be established for each RDP committee at the Twin County Federal Credit Union using the RDP's EIN with the RDP state treasurer being made a co-signatory for reporting purposes.

Precinct caucuses shall be hosted by an officer (PCO) who shall collect \$3 admission, moderate the caucus, and deliver funds and voting to the Legislative District Assembly (LDA).

IV. PROCESS

RDP precinct caucuses shall be held quarterly and proceed to the LDA within two weeks, which said LDA shall be restricted to caucus attendees only.

Resolutions of any type or nature may be read and submitted at a caucus for a vote at the subsequent caucus if sponsored by two RDP members and not adverse to the principles and intents of this charter.

Caucus sign-in and voting shall be taken at the door according to Washington State practice, each

The Legislative District Assemblies shall administer and elect representatives to convene each of the city, county and state conventions.

Charters for state, county or legislative district sub-committees shall be approved by a majority vote of the included caucuses.

V. RULES

A vote may be had upon a motion, properly seconded, for exclusion of a caucus participant for covenant violations, with a written appeal reserved to the legislative district meeting or, failing in such an appeal, to the state courts for review by certiorari if brought within thirty (30) days.

RDP processes may be used to endorse candidates of any political party, with candidates standing for the RDP and voted by a majority vote of caucus assembled to have priority consideration.

This Charter shall serve until amended by resolution of the membership initiated at a caucus assembled and approved by a majority vote of a majority of caucuses represented in majority of Legislative District Assemblies assembled in State Convention.
